## Chambers Diversity Data Survey 2020

Diversity data in respect of Chambers was collected in December 2020. The data was collected in accordance with the requirements of the Bar Standards Board (BSB), as set out within the Equality and Diversity rules of BSB Handbook. The information is set out below. There are 132 members and staff at Twenty Essex, of whom 102 are members and pupils and 30 are employees. Of the barrister members, 28 are Queen's Counsel (QCs), 53 are junior barristers and 4 are pupils. There are 17 full time arbitrators. A number of individuals responding to the Diversity Data Questionnaire did not consent to the use of their data where the number of individuals identified within their particular characteristic/category was fewer than ten. Therefore, we have not published these specific charts. The remainder of the charts are given below, breaking down the respondents to the survey by category (everyone, silks, MOCS, juniors, pupils and employees). We are not able to report on arbitrators due to some not consenting for data publication when categories contained fewer than ten individuals.
